6. COVID 19 pandemic has severely affected the business environment and the economy. In order to reduce the impact of the pandemic, a nationwide lockdown was announced by the Government on 24th March 2020 and consequently, the Company's Plants and offices were closed. However, post lifting of lockdown in a phased manner the Company's operations have resumed, though not at the full level which prevailed prior to lock down. Jun '20 Quarter has witnessed a drop in Total Revenue of the Company.

7. The figures of the previous periods have been reclassified / regrouped whereever required to confirm to the current period presentation / classification. These are not material and do not affect the previously reported net profit or equity.


